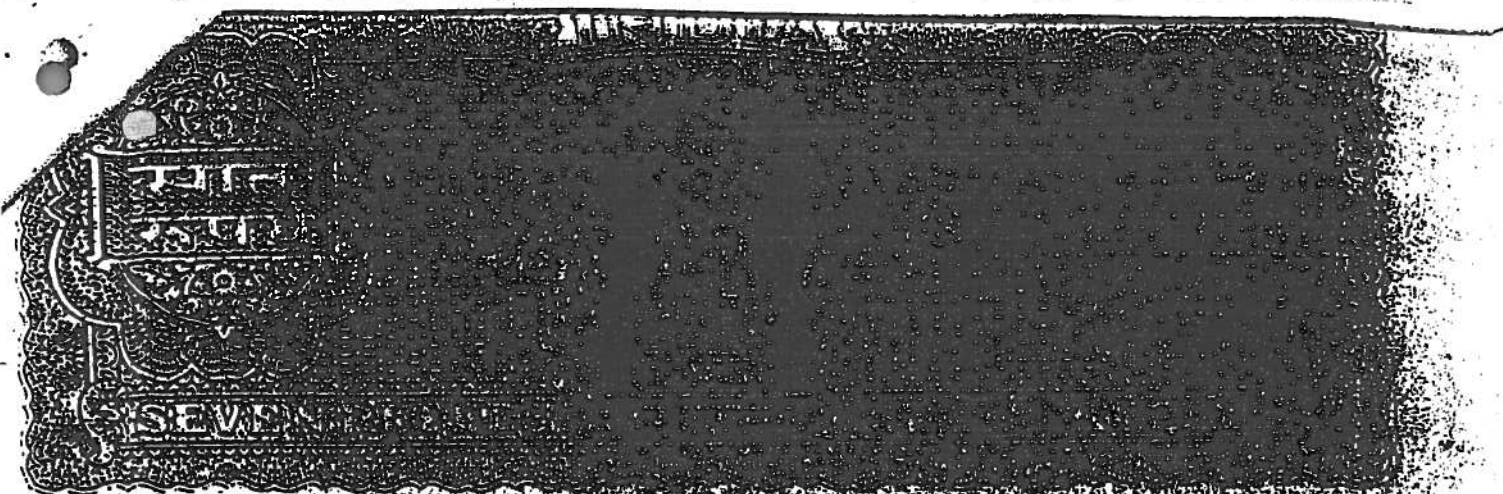

- (ii) All donations, contributions and payments received by the TRUSTEES from any person for the purpose of carrying out, implementing or administering the objects of this Trust.
- (iii) All profits arising by the realisation of any of the investment of this Trust.

(2) We shall be the First Permanent Trustees of the Trust and shall hold Office for our life, Founder Trustee Shri P.N.Parameswaran shall be the Managing Trustee during his life and there-

after Smt R. Jayalekshmy shall be Managing Trustee for her life. Thereafter or during his/her life time, the Managing Trustee shall be nominated by him/her out of the Permanent Trustees.

(3) The Permanent Trustees shall have the power to co-opt 1 (One) Permanent and 2 (Two) Additional Trustees and fix the terms of office of such Additional Trustees,

(4) Any vacancy in the Permanent Trustees shall be filled up at the discretion of the surviving Permanent Trustee or Trustees as the case may be and who shall have similar powers as the Permanent Trustees herein.

(5) The non appointment of a Permanent Trustee in any vacancy shall not invalidate the Trust or any action taken on behalf of the Trust.

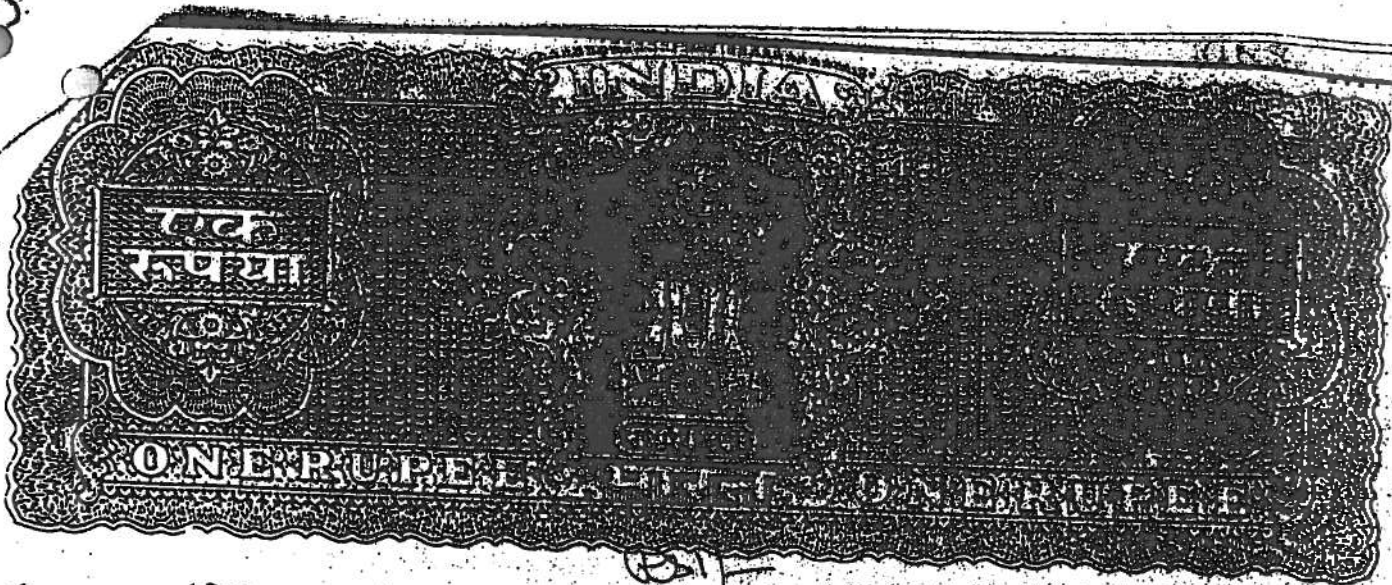
(6) The following are the powers of the TRUSTEES:

- (iii) The funds of the Trust shall be invested in accordance with the provisions of the Income Tax Act or as may be required as per Regulations made under the Income Tax Act as the case may be.
- (iv) The TRUSTEES are authorised to develop, sell, lease, mortgage or otherwise deal with any property of the Trust (both movable and immovable) as may be found convenient from time to time.
- (v) The TRUSTEES shall not carry on any business with the funds of the Trust other than a business which is carried on in the course of the actual carrying out of a primary purposes of the Trust as per provisions of Section 13(1) (bb) of the Income Tax Act, 1961 or as may be permitted by the Income Tax Act.
- (7) The FOUNDERS hereby create, constitute and declare this Public Charitable Trust which shall be known as DEVI ACADEMY,

and transfer to and vest in the TRUSTEES the sum of Rs.501/- to be held by them in Trust for the benefit of this Trust and for carrying out the objects of this Trust.

(B) The objects of this Trust shall be as follows:-

1. To establish and maintain the Academy for conducting studies and research in technical, commercial, financial, sociological, philosophical, psychological, political fields etc., and prepare research papers or reports connected with such aforementioned subjects.
2. To render aid to handicapped and disabled persons either financially or otherwise.
3. To aid handicrafts, to establish or to finance Institutions founded for developing handicrafts.
4. To start, establish, run and maintain Educational Institutions, Schools and Colleges-general, Technical, Medical, Vocational or otherwise and impart teaching, coaching and training for pupils and students for general professional and other courses.
5. To award, scholarships to pupils and students, donations, books to needy, run a book bank for loaning books to students and also donate to existing book banks having similar objects and establish libraries.
6. To receive donations from similar Institutions and the public to further the objects of this Trust.
7. To establish, maintain and conduct institutions and or colleges to further the objects of this Trust and to train people to enable them to carry on the activities and objects of this Trust.
8. To give donations to such institutions which are already carrying on research and studies on various fields in consonance with the objects of this Trust.


9. To establish, maintain homes and institutions for the poor, disabled and physically, mentally handicapped persons.
10. To aid institutions and to establish institutions for the improvement of music, dance, drama and such other fine arts.
11. To establish and maintain the institutions for making studies and surveys in agriculture, dairy development, fisheries, forestry, horticulture, drugs, chemicals and pharmaceuticals including fertilisers, techno-economic studies and surveys in communication, general education and physical education and culture including festivals, electronics and allied studies, power and energy studies, industrial and economic surveys including labour and rehabilitation, public health studies and similar technical socio-economic political, commercial and financial etc., studies.

(9) The TRUSTEES are authorised to frame rules for the proper conduct of the Trust, but any such Rule shall not be against the objects of the Trust or any other conditions of this Deed of Trust.

(10) The TRUSTEES are authorised to collect any donations or fees for carrying out the objects of the Trust but such collections shall be only to meet the actual cost of expenses without any element of profit.

(11) The TRUSTEES shall have power to accept donations as money or otherwise for the purpose of the Trust.

(12) This Trust is irrevocable and no part of funds of the Trust or income of Trust shall be taken directly or indirectly for the benefit of the authors of the Trust or of the TRUSTEES as the case may be,

(13) All decisions of the Board of Trustees shall be taken over unanimously or by majority and the Managing Trustee will have the casting vote if there is equal division. The Board of Trustees shall meet as often as possible or convenient to transact business and take decision by circulation of papers.

(14) Without prejudice to the powers of the Board of Trustees the Managing Trustee shall manage and administer the affairs of Trust and shall also exercise such powers and functions as may be delegated to him by the Board of Trustees.


(15) The management and administration of the Trust shall vest in the Board of Trustees. The quorum of the meeting shall be two trustees. The Managing Trustee shall have powers to appoint secretarial, clerical and medical staff that may be required for the purpose of administering the Trust and fix remuneration and terms of employment of persons so appointed and dismiss, terminate or remove from service all or any of them and appoint others instead.

(16) The properties and funds of the TRUSTEES shall vest with the Board of Trustees.

(17) The Board of Trustees shall have power to acquire, hold, enjoy and deal with and dispose of properties every description, both movable and immovable for and on behalf of this Trust. This power shall include power to sell, lease, mortgage or otherwise alienate the property of this Trust.

(18) The TRUSTEES shall have power to invest the funds of Trust in immovable properties and/or in improvement or construction of buildings.

(19) The fund of the Trust shall be invested in Bank deposits, government bonds or such other appropriate or approved securities as the Board of Trustees may decide and as per the provisions of the Income Tax, Act, 1961.



(20) The Board of Trustees shall have powers to borrow for the purpose of the Trust.

(21) Without prejudice to the generality of the provisions contained in the above clauses, the Board of Trustees may also empower the Managing Trustee to represent or act for the Trust in any matter concerning the properties, funds, investments, borrowings and the making or cancellation of any instruments for any of these purposes.

(22) The TRUSTEES may open Bank Account or Accounts with any Bank or Banks and the accounts may be operated by any two of the TRUSTEES, or by the Managing Trustee or any person authorised by the Board Trustees.


(23) The TRUSTEES shall have power to appoint personnel to organise and promote the objects of the Trust and to regulate their conditions of service, including matters of discipline.

(24) The Board of Trustees shall maintain or cause to be maintained proper and regular books of accounts and shall make up accounts every year.

(25) None of the TRUSTEES shall be entitled, to any remuneration for holding the office of a Trustee of this Trust or for attending the meetings of the Board of Trustees but shall be entitled to be reimbursed from out of the monies of the Trust, all out of pocket, travelling and other expenses that may be incurred by him in the discharge of his duties as a Trustee.

(26) It is hereby declared for the removal of doubts that the objects of the Trust is not for the benefit of any particular religious community.

(27) It is hereby declared that in the implementation of the objects of the Trust or of the conditions of the Trust, the decision of the TRUSTEES shall be final and cannot be called into question by any person or group of persons or other bodies whatsoever.







